6	High and fast river flows	Health Safety	Risk of drowning or serious injury	5	4	20	Do not attempt to wade in high flows where water level is greater than 0.5m. Always wade slowly and use staff. 14	Food/Hot Drink Preparation	Health Safety	Scalding from spillage of hot water. Burns from contact with grill / hob. Cutting, slicing, puncturing from use of utensils.	4	2	8	Do not light open fires when fishing. Ensure all portable gas cooking equipment is in good working order and you are familiar with its operation. No fires or stoves are permitted at Barry Ponds or Pysgodlyn Mawr. 15	Slippery, icy or uneven surfaces	Health Safety	Slips, trips and falls. Falling into water possible drowning and hyperthermia where platforms, walkways and bridges are damaged. Unauthorised access to ponds where gates/fences are damaged.	4	2	8	Do not fish from a damaged platform. Report any damage immediately to the Head Bailiff.	4	1	4	Anglers
17	Puncture wounds from hooks. Sharp objects e.g. Needles near outfalls and rubbish in urban areas	Health Safety	Injury or infection from dirty needles etc	4	2	8	Keep away from debris. Wade slowly in turbid waters and use a staff. Avoid fishing immediately downstream of sewage outfalls. Carry a basic first aid kit.	4	1	4	Anglers & Bailiffs
18	Electric shock (from electric fencing)	Health Safety	Risk of minor injury if fence is touched. Anglers & bailiffs with heart conditions, particularly individuals that have implanted cardiac devices should check the possible risk with their GP.	4	2	8	Agricultural electric fencing is pulsed at 1s intervals at low power but at high voltage in order to deter predators. Do not touch electric fencing. Take care when shipping poles, rods and landing nets backwards to ensure that no contact is made with the electric fence. Wash waders and any other equipment that has been in contact with the waterbody in tap water removing all debris and dry in the open air.
